State Team Leaders have been selected for most Teams. The Green and Sustainable Chemistry Team is still looking for one Team Leader, which has been a challenge because it is a non-traditional ITRC subject area. Reyes is working with Mimi Johnson (WI), Team Leader, the proposal writers, and other associations to identify a second Team Leader. One should be identified prior to January 2024.

Project Advisor interviews have started and will conclude on November 25. Selections will be made shortly after they conclude.

New ITRC Membership Tools

ITRC has begun using Member365 as a new membership registration and renewal platform.

- All 2024 members that were registered in the old Connect platform have been migrated to Member365 and can login with their email address. Account details were emailed to these members on November 14-15.
- All other members will need to create an account for approval.

Once a member, ITRC Project Team collaboration, meetings, and day-to-day work are managed in ITRC's new Microsoft Teams platform. The platform syncs with Member365, and members with an active ITRC membership are connected to Microsoft to select and participate in Project Teams.
